## Raton High School teacher is published in national magazine

Tim Keller teaches high school English and Civics, but has a passion for photography and a love of the southwest that is obvious in his photos. Several of his photos of a cattle drive, accompanied by his story "Driving on Blacktop," can be found in the January 2009 issue of "Western Horseman," a pre-eminent US horse magazine. His interest in photography came naturally at a young age when he began developing his own surfing photos which he had taken with a friend's camera. What started out as a hobby with borrowed cameras has become a serious pastime since his purchase of a Nikon300 digital SRL camera and several lenses. For several months he photographed everything and anything he could, amassing a wonderful collection of photos of northeastern New Mexico. Later, as the photography bug grew stronger, Keller began approaching several magazines that feature southwestern, New Mexico stories.

The "Western Horseman" sent Keller a writer's guide, which stated that they normally do not publish articles from freelance writers or photographers. However, someone was impressed with his work, and they decided to use it in the January issue. Keller's photog-

raphy was recently awarded the "Best in Photography" at the Raton Arts Council's annual International Art Show in Raton, the largest art show in northeastern New Mexico, and he has two photos in the finalist pool for New Mexico's Art in Public Places program, which was just announced this month. Keller will continue to pursue other magazines in which to publish his photos. His work can be seen in various galleries in Raton and Des Moines.

Keller lives in Des Moines with wife, Christina Boyce, owner of Studio C. They will be celebrating ten years of marriage, and twelve years together before that. According to Keller, they met in Santa Fe when he was organizing weekend entertainment for the Galisteo News, a coffee shop on the corner of Don Gaspar and Water Street. Christina, who was working on costuming for the "Taming of the Shrew" for the New Mexico Repertory Theater and with the Santa Fe Opera, came in one evening, and as they say, "The rest is history."

## Weather alert: frigid temperatures freeze pipes

Thousands of families have one or more rooms in their homes ruined and their lives disrupted each winter by water pipes freezing and breaking, warns the nation's largest insurer of homes, State Farm Insurance®.

According to the Institute for Business and Home Safety, claim payments by all insurance companies over the past decade for these kinds of losses have exceeded \$4 billion.

When the outside temperature drops below 20 degrees

Fahrenheit (minus 6 degrees Celsius), water pipes in homes with little or no insulation are likely to freeze and break. In fact, a one-eighth inch (3-millimeter) crack in a pipe can spew out more than 250 gallons of water a day, destroying floors, furniture, appliances and personal items.

Homeowners can avoid frozen pipes by following these helpful tips:

- Make sure there is adequate insulation where pipes run along outside walls, floors and ceilings.
- Disconnect outside garden

hoses; wrap exposed pipes with insulating sleeves or tape, and seal foundation cracks that let arctic air freeze pipes in crawl-spaces.

If a severe freeze is predicted

■ Open cabinet doors to allow heat to get to piping under sinks and vanities near exterior walls, and

■ Run a small trickle of water at vulnerable cold and hot faucets.

Before you go away for the holidays

- Set the thermostat in your house no lower than 55°F (12°C).
- Ask a friend or neighbor to

check your house daily to make sure it's warm enough to prevent freezing or

■ Shut off and drain the water system.

■ Be aware that if you have a fire protection sprinkler system in your house, it will be deactivated when you shut off the water.

## Projected Christmas holiday travel third largest since 2000

AAA Colorado forecasts 63.9 million Americans, or 21 percent of the national population, expect to travel during the Christmas period. Although travel is expected to be down 2.1 percent compared to last year, the number of Americans traveling this Christmas represents the third largest volume since 2000. In 2007 there was a record high of 65.3 million holiday travelers and 2006 had 64.7 million travelers.

Travel in the Western region will be down 1.9 percent with 15.5 million Western residents traveling more than 50 miles away from home. Travel by automobile will be down 1.5 percent from 2007 despite a gas price that is \$1.27 less than 2007. The average price for a gallon of regular unleaded gas in Colorado is \$1.60.

Air travel will be down 6.7 percent in the Western region and 8.5 percent nationwide. Travelers should expect different trends in airfares depending on the week of travel. Airfares nationwide during Christmas week are down nine percent compared to 2007. Airfares for the week of New Years are up three percent. AAA Colorado advises air passengers to check with their airline or travel counselor about additional fees before booking a trip. Most airlines continue to charge fees for checked baggage and other previously complimentary services like beverages and snacks.

Nationwide, Americans can expect lower hotel rates and higher car rental rates throughout the holiday season. Similar to Thanksgiving, about two-thirds, 64.2 percent, of Christmas travelers plan to stay in the home of friends or family during their trip.

With Christmas falling on a

Thursday this year, it appears that travelers are looking forward to starting their holiday trip early. Almost a third, 32 percent, say they expect to begin their holiday travels on or before Sunday, Dec. 21. After a brief pause on Monday, travel departures pick up with 13 percent traveling on Tuesday the 23rd, and peak on Christmas Eve with 17 percent. One in ten holiday travelers are likely to travel on Christmas day, while 14 percent are planning to travel after Christmas through Dec. 31. Almost 10 percent of travelers are not sure when they will begin their holiday trip.

Travel projections for the Christmas holiday are derived from the Travel Industry Association's Holiday Travel Forecast Model. The model was developed based on consumer travel intentions and TIA's quarterly travel forecast data. The travel intentions data is collected through an

online survey of nearly 2,300 adults nationwide, supplemented by an additional 5,000 Americans surveyed from the top 10 states of travel origin in the United States. Historical travel volume and other economic data such as GDP, disposable income, employment and travel costs are also incorporated into the model. Analysis of the data and the forecasts are produced exclusively for AAA by TIA.

The Chicorica, for which the event is named, is the Chicorica Creek which flows from the spillway of Lake Maloya, travels past the visitor's center, through the ruins of the Sugarite Coal Camp, then eventually meets up with the Raton Creek about nine miles upstream from the Canadian River. According to Dye, Chicorica is a word used for "abundance of birds," which certainly applies to the Sugarite Canyon State Park.

**Discounted telephone service available**

The Colorado Public Utilities Commission designated CenturyTel as an Eligible Telecommunications Carrier or ETC within its service area for universal service purposes. The goal of universal service is to provide all Colorado citizens access to essential telecommunications services.
