

Farley District in Colfax County gets new tanker

Colfax County Commissioners got an up close look at the Farley district 3000 gallon T-300 Kenworth Tanker at its regularly scheduled meeting on Tuesday.

The tanker, which was purchased solely through a grant from the New Mexico State Fire Protection Grant, was purchased from Fouts Brothers in Smyrna, Georgia for \$148,000. Farley was one of several departments that applied for the grant which is open to ISO class 9 or 10 departments and is used to improve its ISO rating. The rating, which determines risks for fires and other damages, is used to determine insurance rates. With the addition of the tanker in the Farley district, the risk is lowered and therefore would improve the ISO rating,

meaning a possible revenue savings for the county.

Colfax County Manager Don Day informed the commissioners that the entire county, except for portions in the Philmont Fire District and Moreno Valley district, is under a fire ban because of the extremely dry conditions. Vermejo Park has requested that it be placed under the same fire ban. The ban prevents any open fires in these areas until further notice.

During a special budget workshop that followed the regularly scheduled meeting, the commissioners consulted with Jeff McWhorter, a certified public accountant who has been contracted by the County for the audit that it is undergoing, about implementing a better system of managing its inventory. Commissioner Hite suggested

would allow information of date received, inspection date, and when each item is added to the county's inventory. McWhorter stated that the county needed an accurate baseline of inventory, equipment that costs more than \$5,000 and that equipment between \$1,000 and \$4,999.99, so that depreciation values can be listed and compared. Manager Day told the commissioners that his office is currently securing that information, but Commissioner Hite stated that he believed each department head should be responsible for supplying an accurate listing of its own inventory and should be completed on a regular basis, perhaps monthly. The goal of the commissioners is to have a complete inventory of each department before May 1.

Bingaman bill would help strengthen Medicaid, save taxpayer dollars

WASHINGTON - U.S. Senator Jeff Bingaman today renewed his effort to pass legislation that seeks to protect and strengthen Medicaid while saving taxpayer dollars.

More than 50 million Americans rely on Medicaid, the federal-state funded health initiative for low-income individuals and families. Medicaid plans are administered by states and/or managed care organizations contracted by states. Unlike states, Medicaid managed care organiza-

tions currently are not eligible for rebates on generic and brand name prescription medications and therefore they are being charged a premium price for those drugs.

To ensure that states and the federal government are not overcharged for medications, Bingaman today introduced the Drug Rebate Equalization Act of 2009. This legislation will allow health plans run by Medicaid managed care organizations to receive rebates on prescription medication just as states do. Not only will this legislation ensure that health plans maintain a comprehensive care coordination system for their patients, but it also has the ability to save the federal government as much as \$11 billion over 10 years.

"This bill will not only allow Medicaid beneficiaries' rebates on prescription medications, but it will also save taxpayer dollars," Bingaman said.

The Medicaid drug rebate ensures that State Medicaid programs receive the best price for prescription drugs for their beneficiaries. This policy was included in President Obama's 2010 budget request that was released two weeks ago.
