Have a Cup Café is once again open on the main highway through Des Moines, N.M. Open briefly last summer, Debbie and Andy Foster of Stuart, Florida, are realizing their dream of creating a "warm and welcoming atmosphere" for customers. ### **Grassland protection** opportunity extended

ALBUQUERQUE, NM - New Mexico has a chance to be just a little bit "greener" as the final date for acceptance of applications for 2009 funding under the Grassland Reserve Program (GRP) has been extended to June 5, 2009. The Grassland Reserve Program is administered by the USDA-Natural Resources Conservation Service (NRCS), and provides conservation opportunities for protection of New Mexico grasslands from development through permanent easements or term-specific rental contracts.

"The State Technical Committee that advises NRCS is encouraging GRP applicants in Union, Harding, Quay, Curry, Roosevelt, Lea, DeBaca, Chaves, and Eddy counties this year," said Norman Vigil, assistant state conservationist for programs.

The condition of the range is a heavily weighted ranking factor in this very competitive program, with priority given to grasslands that are in the best condition. Other ranking factors include the diversity of ecologi-

cal sites within the area considered, threat of conversion to nongrassland uses, and viability of easement management.

The Grassland Reserve Program has historically enabled some of New Mexico's finest land stewards to ensure their private rangeland is preserved as rangeland, and not converted to other uses such as urban development, cropland, or for industrial purposes. It provides payments for agreements that restrict development either on a permanent basis or termspecific arrangement.

"In addition to enabling ranchers to preserve their legacy, the Grassland Reserve Program benefits New Mexico as whole by protecting our watersheds, sequestering carbon, and enhancing wildlife habitat," said Vigil.

The agency advises that while a cut-off date for 2009 funding is necessary, applications for the program are accepted on a continuous basis for future opportunities.

### Springer History Museum & Santa Fe trail interpretive center

Interpretive Center/Museum docent Angela Esquibel, will present the June 2009 Family History Display, featuring Frank Springer, "Renaissance Man". Springer was born in Wapello, Iowa on June 17, 1848 to Francis and Nancy R. Springer. He was well known for his fields of forte as an educated lawyer and paleontologist as well as his work on New Mexico's Maxwell Land Grant. In 1873 Springer moved to Cimarron working as an attorney for the Maxwell Land Grant Company and the Atchison, Topeka and Santa Fe Railroad which laid the foundation for his fortune to purchase the CS Ranch, named after his brother, Charles Springer: The Springers' importation of purebred Hereford cattle from Iowa being one of the first excursions of its kind. Frank was the attorney for the Dutch company that purchased the title to the 1.7 millionacre Maxwell Land Grant in

1878. He was the founder of the

New Mexico Normal University (Highlands) in Las Vegas, NM, as well as the Museum of New Mexico and the New Mexico Art Museum in Santa Fe, not to mention the many more accomplishments he is known for. Display will be ready for viewing at the media center Tuesday, June 9th,

The museum is open on Tuesdays through Saturdays from 10:00 a.m. to 3:00 p.m. Admission is free on Saturdays throughout the year. We welcome and encourage the public and media to visit the museum throughout the month to learn of the history of the Santa Fe trail and region area.
