City Manager Jim Soltis is hanging up his tie after 14 years of service.

City Manager Soltis tells city he is retiring in 2 months

After 14 years as Trinidad city manager and nearly a lifetime spent in city government, Jim Soltis has decided to retire to spend more time with his family, effective in two months.

Soltis delivered his retirement letter to Trinidad City Council after Tuesday night's executive session and confirmed his intent Wednesday morning.

Council is expected to publicly acknowledge and accept his retirement letter as a formality at next Tuesday's meeting.

"Retirement is something I'm looking forward to doing, some things that I have been putting off for a long time and being able to spend some time with my daughters," he said. At this point, Soltis said he

"I think there has been a tremendous amount of accomplishments done when you look around and see all the improvements throughout the city, the walking trail, the downtown streets, the swimming pool, the parks, all community assets," he said.

Soltis said he is required by his contract to give two months notice to the city or the first week of July to find a successor. "I said to them that if they needed me to be around a little bit longer, to make sure that transition gets done, I agreed to that.'

Soltis is still actively involved negotiating with the city employees union, trying to hammer out an agreeable contract to both sides and plans to meet with union management again later this week. His last year and a half in office has been especially tough with the local, state and national economic downturn forcing the city to make some unpopular decisions in the wake of a \$900,000 budget shortfall resulting from a substantial 2009-10 loss of city sales tax revenues. At this point, Soltis said he hasn't given much thought as to who might be a worthy successor. "I think they (council) need to look around to see if anybody is interested before they go outside (the city), but that's going to be their decision, not mine," he said.

RATON - The casino and racetrack proposed for the southeast side of Raton took a significant hit Tuesday when the New Mexico Gaming Control Board voted 5-0 to revoke the project's gaming license.

La Mesa Racetrack and Casino President Michael Moldenhauer is expected to appeal the decision, according to La Mesa spokesman Tom Carroll.

'If this doesn't go through, then Raton will not have a racetrack or casino. Michael Moldenhauer has decided to fight this to keep it in Raton. He's going to appeal and go through all the legal hoops and file a lawsuit to keep it in Raton," Carroll said. Depending on the outcome of **Continued on page 11**

County gets head start on noxious weed control

Las Animas County has started spraying for noxious weeds, getting off to a much earlier start than it did one year ago. The county has about \$15,000 from a grant by the Department of Agriculture, \$12,000 of which was amended from 2009. Along with monies from the State Land Board the county has started spraying in the eastern part of Las Animas County.

"I think the early start this year is because we have better communication between Leslee (Fresquez county's Deputy the Administrator), Phil (Dorenkamp, Road and Bridge county **Continued on page 2**

RHS band wows them in the **Show-Me State** By TIM KELLER

RATON - Fresh off its showing of "Excellence" in the New Mexico State Concert Band Championships, Raton High School's band traveled to St. Louis, Missouri, last week to win further honors Friday at the St. Heritage Louis Festival. Competing against dozens of bands from many states, the Raton musicians earned 2nd place in their division, topped only by Paragould High School of Paragould, Ark.

Band Director Russell Woods was even more proud of an unexpected award. Festival organizers sent "spies" among the performing groups, observing them at their hotels, restaurants, and theme parks. They interviewed the competition judges and festival organizers. After compiling all their notes, they awarded one "Spirit of St. Louis Award" for the entire festival, to "the one school that best represents its community and school." The spirit award went to the Raton High School Band.

"At the awards banquet, when they called our school name, there was an initial silence," Woods recalls. "Then we all screamed and cheered as it sank in that it was our school they'd called. I was really most proud of that award."

The first New Mexico band to ever make the trip, Raton competed in the small schools division against bands from Iowa, Illinois, Missouri, Tennessee, Kentucky, Oklahoma, and Arkansas. Eighteen band members made the trip on the school's activity bus, leaving Wednesday afternoon and returning to Raton the following Monday morning, May 3.

Three university-level music professors evaluated performances at the nationally accredited educational music festival. All bands were rated and ranked according to their performance level, with Raton's 2nd place finish a milestone in the band's history.

Woods expressed appreciation for all the band's supporters, saying, "We've only been able to do this through the generosity and support of all the people who have come to our concerts and helped us with fundraisers. We really appreciate them."
