Box full of child's play spills across Shuler stage

Special to The Chronicle-News RATON — It was a terrible, horrible, very bad day for Louis and Tabitha when they succumbed to curiosity and opened the big box that had appeared in their New York City East Village walk-up apartment. The wooden crate turned out to be, literally, Pandora's Box, and it was full of their worst nightmares, famous villains from the world's favorite fairy tales.

The weekend Shuler Theater production of "Once Upon a Pandora's Box," a 2007 stage play by Monica Flory, showed the playwright to be in close touch with her inner child, which is not to say that she's in command of it: The children in her play spill all over the stage in frenetic silliness.

Watching the 65-minute romp often felt like being a parent peaking into the children's playroom without them being aware of being watched.

It was children's play acting without restraint. There was the Queen from Snow White, played with relish by Zoe Gomez, and the Big Bad Wolf played by Spenser Willden. Meigan Deater was a very mean Witch, Laura Robertson a petulant Fairy #13, and Ryan Hull an antic Rumpelstiltskin called "Rumple."

Once they're let out of the box, they take captive their two unwitting hosts, Louis and Tabitha, played by Christopher Mandonado and Nathaly Torres. The

troublemaker behind all this was none other than Zeus, played by the troupe's youngest member, Junior Torres, but voiced by high school senior James Neary.

Before the villains were boxed, they ran rampant

throughout the auditorium and stage, speaking in their original languages while Stone Phillips, as Translator, calmly stood to the side providing the audience with translations.

Johnny Gentry bookend-

ed Phillips's Translator by showing up near the play's end as Reporter, standing in the same spot to give the audience news reports of the goings-on after it finally occurred to the villains to leave the tiny apartment and unleash themselves on New York City.

Rounding out the cast were Asia Gentry as Angela, Breanna Brown as Beautella, and Rachyl Hull as Esperella, visitors to the apartment. While it was, indeed, all child's play, it was not without guiding hands, albeit invisible ones.

Director Gail Dixon-Willden again showed her gift for wrangling children without diminishing their natural playfulness. This was her annual foray into mounting a play for the community's 8- to-12-yearold actors, a practice that is already paying dividends for other plays, such as the annual "A Christmas Carol," when casting calls for children's roles bring practiced young actors.

Bill Fegan produced the play for The Santa Fe Trail School for the Performing Arts. Cian Hazen was the technical director and designed the lighting, which was run by Tessa Fleming. Ashley Atwater ran the sound, which was designed by Hazen and Willden and recorded by Billy Donati. Desiree Martinez was the assistant director, aided by assistant stage manager Haley James and crewmembers Megan Petrie and John Davis. Ursula Garcia and Misty Gomez costumed the young actors, and someone uncredited — had a ball in designing and applying their make-up.

In addition to public performances Friday and Saturday nights and Sunday afternoon, the Raton Public Schools treated its kindergarteners, first and second graders to Friday morning performances at the Shuler. By all appearances, a zany time was had by all.


