RATON — The Shuler Theater celebrates its 97th birthday Friday night with its second annual student Poetry Rocks! program. Last year's show was such a success that a catered reception has been added to follow this year's performances.

Raton High School students have been working in their English classes for weeks Albuquerque poet-educators Manuel Gonzalez and Tracey Dahl, producing original poems they share aloud with their classmates. Many will sign up to share with a larger crowd at Friday's all-day Annual Poetry Marathon in the school library.

Last year, 140 students shared their new poems, about a third of the student body. Thirty-eight of them took the next step and mounted the Shuler stage that night to share with parents, families, and the community.

The National Poetry Month festivities join last fall's Poetry Out Loud competition that sent Raton freshman Clair Willden to Santa Fe to represent Raton in February's New Mexico state competi-

The Whited Foundation has sponsored Raton's Poets-in-the-Schools program for two years, with the professional poet-educators provided by New Mexico CultureNet.

Earlier this year, donations at a KRTN Movie Night at the El Raton Movie Theatre produced enough funding to add a reception after Friday night's student poetry performances. Mexican food will be prepared by Raton High School's Culinary Arts catering team and served next door to the Shuler Theater at the Isabel Castillo Center for the Performing Arts.

Showtime at the Shuler Friday is 7 p.m. Admission is free, with the reception following immediately after the show.

First Presbyterian Church votes to join more conservative group

COLORADO SPRINGS, Colo. — The First Presbyterian Church in downtown Colorado Springs has voted to split from its denomination and align with a new, more conservative organization.

The vote ratifies a decision made by church leaders in January to leave the Presbyterian Church (U.S.A.), after the church voted in 2011 to allow openly gay ministers to be ordained.

Of the nearly 1,800 church members, about 1,700 voted to dismiss the old church and switch to a more conservative denomination called the Evangelical Covenant Order Of Presbyterians.

Groups upset by proposed gas lease auction settlement

CARBONDALE, Colo. — Five Colorado conservation groups are criticizing a proposed settlement with two natural gas companies accused of rigging auctions of four gas leases on federal land.

The groups including Western Colorado Congress and Wilderness Workshop say the U.S. Department of Justice is letting the companies off with a "wrist slap."

Gunnison Energy Corp. and SG Interests were accused of agreeing in 2005 not to compete against each other in the auctions. Federal prosecutors said in February that each company agreed to pay \$275,000 to settle the claims. The companies aren't admitting guilt. The public was given 60 days to comment on the settlement before a judge decides whether to approve it.
