

THE ARTS Scratching the surface provokes laughter in Shuler's 'Earnest'

The Shuler Theater's Kaleidoscope Players provide what's called "high entertainment value" in their current production of Oscar Wilde's comedy "The Importance of Being Earnest." That value is best measured by the incessant laughter ringing from the audience from start to finish.

The plot and characters are minimal and trivial, but the dialog and acting are not. The many pleasures come from Wilde's witty lines delivered with accomplished acting that makes unlikeable characters highly engaging. Great comedy depends upon great acting, and this production has it.

Wilde is endlessly inventive at throwing one complication after another at his protagonists, two young men and the two young women whom they fancy. Mostly the men create their own complications: The men are shallow, their self-absorption



all-encompassing. It is a perfect play for the age of Facebook.

And online chat rooms: These people talk to each other without knowing each other, and without knowing themselves. They are their own creations, but they change on a whim. Because they are members of the upper crust, they have the leisure to be silly.

Wilde has great fun with them, giving them dialogue that sends ripples of laughter through the audience in steady rhythms. Of course, the characters themselves rarely know they're so funny, and the actors couldn't be better at toeing the line

Blake White's character, John Worthing (a.k.a. Jack, a.k.a. Ernest), is a serious 29-year-old intent on becoming engaged to Miss Gwendolvn Fairfax, played by Tamara Todres with a good mix of sternness and sass. White begins almost as the comedy's straight man, with few verbal zingers, but the deeper he gets into complications, the more his expressions and physical comedy place him in the center of the laughter. His counterpart, Algernon Moncrieff (a.k.a. Ernest), is wicked fun from the

start. Played by Ian McCabe, the irresponsible rake early gets many of Wilde's best lines. Initially cynical about marriage, he says, "Divorces are made in Heaven." And "In married life, three is company and two is none." In a line that could have been written today rather than in 1894, he says, "More than half of modern culture depends on things that people shouldn't read.

Eventually the focus shifts from the two men to the two women before everyone comes together in a madcap third act. Nora Leahy plays Cecily, who is even more selfinfatuated than her suitor, Algernon. She's already lived their relationship in her elaborate imagination, before they meet. Once she gets him, she is incapable of patience. Faced with waiting years for Algernon, she can't. "I can't wait five minutes ... for anything!'

By the third act, the four lead actors are in balance, bouncing off of each other with skill and relish. The supporting cast, too, is better than one could expect in any small town, except the one that has the Shuler Theater in it.

Sara Kowalski plays two roles, Lane and Merriman, the servants to Algernon and Cecily, respectively. Her butler, Lane, may be the only character to recognize everyone else's silliness. Both Lane and Kowalski do their jobs impeccably.

Matt Campbell's Rev. Canon Chausible and Brenda Ferri's Miss Prism are small but important roles done well. Barbara Farrar returns to the Shuler as the play's matriarch, Lady Augusta Bracknell,

Gwendolyn's mother and aunt to Algernon — of whom she remarks, "He has nothing but he looks everything." The surface is always paramount.

As the play approaches its zany climax, all the pieces can't slip into place without Lady Bracknell's approval. Despite last Thursday's opening-night tentativeness, Farrar's character provided a critical pivot around which all the other characters revolved.

Director Tom Evans gets kudos for an expert production that includes his scenic design and a cast he assembled and coached to comic perfection. Leahy and McCabe get credit for some of the Shuler's best costuming in recent memory, with Blake White's two-tone brown-and-white shoes deserving special notice.

The final performances of "The Importance of Being Earnest" will be Thursday and Friday nights, July 10-11, at 7:30 p.m. The season continues Saturday night with the opening of Henry James's "The Turn of the Screw" General admission tickets are \$15 for adults, \$13 for seniors and \$5 for students and are available at the Shuler Theater. The scouts left the Spanish Peaks Scout Ranch on school buses and sheriff's vehicles before dawn Tuesday after rain caused a creek on the property near Walsenburg to rise.
