Yvonne O'Brien's photography opens at Studio C

Studio C, the art gallery in downtown Des Moines, New Mexico, will host a reception Friday from 3:00 to 6:00 pm for the opening of "light, structure, space", a show of fine art photography by Cimarron artist Yvonne O'Brien.

The dozen images on display were all shot on film. "I use 35mm to 4"x5" traditional equipment and film to achieve maximum quality," O'Brien says. Originally from Chicago and northern Indiana, she moved to Cimarron nine years ago after more than a decade engaged in museum education and photojournalism in the Kansas City area.

"It seems what attracts my eye has been with me since childhood," O'Brien says. "Growing up in Chicago left strong impressions of structure and space of a huge city on the edge of a great inland sea, Lake Michigan. Then the different landscape of Indiana woods and back roads had the same lure. While living in Kansas City, that city's architecture, followed by projects in the Flint Hills of Kansas, afforded me many opportunities with both structure and landscape. Now,

in New Mexico, the challenges and joys of trying to capture the essence of the southwest's landscapes are many."

O'Brien first encountered Des Moines two years ago when the village purchased one of her photographs through a New Mexico Arts purchase program. The piece hangs in the entryway of Des Moines Village Hall.

The images in the Studio C show reflect O'Brien's strong attraction to nature, informed by her eye for light, structure, and space. This is the latest in a long list of exhibitions O'Brien has had since 1979. Her work is on permanent display in Silver City, Roy, and Des Moines. She's exhibited at the National Museum of Women in the Arts, the Hubbard Museum of the American West in Ruidoso, and at galleries in Raton, Cimarron, Angel Fire, and throughout Kansas.

Yvonne O'Brien's show "light, structure, space" will be on display at Studio C, on Highway 64/87 in Des Moines, from Friday through June 21. The gallery is open Thursday through Sunday. Additional information is available at Studio C, 575-278-3517.
