

Animal lovers blast grandma who abandoned children's pet

DEAR ABBY: I am writing in regard to the letter from "On the Fence in Nevada" (Sept. 11) (whose mother-in-law dumped her grand- children's cat on the side of the road). I work as an animal safety officer for the sheriff's office, and I also volunteer for a local animal nonprofit

There has been an increase in pet dumping as the economy has worsened. While the information you offered was accurate, there are many other reasons not to abandon an animal.

What "Loretta" did was illegal. It's called animal endangerment, animal abuse or animal abandonment. Because the cat did not belong to her, she could also have been brought up on charges of theft. Such charges can carry heavy fines and jail time.

"On the Fence" should know that there are local organizations that can help her brother-inlaw by providing temporary foster care for his pet until he can get back on his feet. Their members are people who will want the cat in their home and who will love it and look after it. - DAWN IN COLORADO

Continued from page 1 work, building its foundation, making comprehensive recommendations involving cost of living adjustments and how to achieve the 2/2/2 Plus goal of creating shared responsibilities, ensuring the long-term sustainability of the plan, while respecting Colorado taxpayers and continuing to provide some degree of inflation protection for PERA beneficiaries that reflects today's economic reali-

period for the 50 percent refund match for future contributions.

■ requiring the 8 percent employee contribution to PERA for working after a member retires.

 \blacksquare revising the COLA (cost of living adjustment) effective date to July

■ requiring a full calendar year of benefits to be eligible for

COLA. \blacksquare expanding the post Jan. 1, 2007, provisions regarding retirement effective date and benefit indexing applicable to persons not eligible to draw a benefit on the effective date of the statute. Also being considered are plans to revise the existing statutory benefit tables to increase the reduction factors for early retirement and to modify the age and service requirement for members not yet vested (except state troopers) to the Rule of 90. Gatlin stressed that pension plan changes need to be phased in over a period of years so people's behavior patterns aren't altered and everybody decides to retire at once over concerns they won't be fully vested. He also discussed the economical pros and cons of PERA members contin-

• creating a five-year vesting uing to work elsewhere after retirement from their PERA employers.

"The bottom line is we want to have a plan of shared responsibilities and we want to ensure the sustainability of the plan,' said Gatlin. "If we don't make changes now, we will be looking at adding \$1 billion to the plan's future liabilities.'

duced a relatively tiny harp, with wire strings and held by one hand. She replayed the Gregorian chant that closed the first series, to let the audience experience the contrasts produced by playing one piece on two different harps. Then she played a lullaby with the lovely title, "Woe Betide Thy Weary Body," fol-lowed by "Castle Kelly." Anderson closed with "The First Noel," augmented with jazz chords.

That left Havill to close with a piece both dramatic

and humorous from his recent "historical medical adventure," set in Washington State, circa 1891, Race for the Dying. Havill, who first came to New Mexico from upstate New York to study English at UNM in 1965, has been an English teacher in Grants and Ruidoso. He and his wife Kathleen retired to Raton in 2002. All along, he's written novels - including four westerns, sixteen Posadas County mysteries, and Race for the Dying, from which he read a dining table scene in which the plot turns on a basket of succulent peaches. Holding a dripping peach between thumb and forefinger, his character points out that peach pits are poisonous, that even something as lovely and perfect as this peach has a dark side.

Audience members milled afterward to ask questions of Havill and Anderson, some buying books and CDs. Boyce was pleased to also sell art off the gallery walls. As the last patron left, she began a daunting cleanup job with a smile on her face after a night of gratitude.

"These projections show what will happen if we don't do something at Colorado PERA," Gatlin said. Plan payout projections calculated out over the next 20 years look rather ominous if serious adjustments aren't done now, he explained.

In other words, any new plan will involve some streamlining, adding specific cost of living restrictions and asking PERA members to have to bite the bullet a bit short-term in order to sustain the plan long-term. Gatlin said lots of pressures are being exerted on PERA to change its plan contribution rates as a result of the economic downturn.
