



completed operations.

c. Comprehensive Automobile Liability insurance with minimum combined single limits for bodily injury and property damage of not less than ONE MILLION DOLLARS (\$1,000,000) each occurrence and ONE MILLION DOLLARS (\$1,000,000) aggregate.

d. Professional Liability insurance with minimum limits of ONE MILLION DOLLARS (\$1,000,000) each occurrence and TWO MILLION DOLLARS (\$2,000,000) aggregate.

Provide the name of your insurance carrier and indicate your ability to purchase and maintain the coverage amounts stated above.

The policies required above, except for the Workers' Compensation insurance, Employers' Liability insurance, and Professional Liability insurance, shall be endorsed to include the City, and its officers and employees, as additional insured(s). Every policy required above shall be primary insurance, and any insurance carried by the City, its officers, or its employees, shall be excess and not contributory insurance to that provided by Contractor. The additional insured endorsement for the Comprehensive General Liability insurance required above shall not contain any exclusion for bodily injury or property damage arising from completed operations. The Contractor shall be solely responsible for any deductible losses under each of the policies required above.

7. Provide a list of any legal proceedings against your firm

or employees of your firm who may be providing services to the Town, and the disposition of each proceeding, for the last five years.

8. Disclose any potential conflicts of interest.

GENERAL TERMS AND CONDITIONS:

1. The Town reserves the right to undertake its own investigation to evaluate a candidate. The Town shall have the sole discretion to accept or reject any, or all proposals, or to abandon the proposal process. The Town may enter into negotiations with any one or more candidates and may permit, at its discretion, a candidate's amendment or supplement of the candidate's proposal.

2. All proposals become the property of the Town upon receipt and will not be returned to the Candidate. Selection or rejection of the proposal will not affect this right.

3. The Town operates under public disclosure laws as part of normal procedures. Proprietary information must be identified and will be protected as far as legally possible subject to the discretion of the Town.

4. Cost of developing the proposal, attendance at the oral interview or any other such costs are entirely the responsibility of the candidate and shall not be reimbursed in any manner by the Town.

5. Failure to conform to the proposal rules, including failure to respond to each item in the Proposal Contents

section of this RFP, or to follow the proposal format requested in the RFP, may lead to the rejection of the proposal. The submittal should contain all information necessary to evaluate the proposal.

6. The successful candidate shall not, at any time, permit any individual employed by the Town or any Town official to benefit because of the financial interest in the candidate's firm, any affiliate of the successful candidate, or subcontractor.

7. The final selection will be based on the Town's evaluation of the written proposal, oral and written responses of client references and on the interview with the candidate, if selected for interview.

8. The selected entity shall be an independent contractor and neither the selected entity nor any of its individual employees, agents or representatives shall be considered an employee of the Town. The Town shall be neither liable nor obligated to pay that entity or any of its individual employees, agents or representatives' sick leave, vacation pay or any other benefit of employment, nor to pay any social security or other tax which may arise as an incident of employment. The selected entity may perform professional services during the term of the contract with the City for other parties; provided, however, that such performance of other services shall not conflict with or interfere with its ability to perform requested engineering services.

9. The Town will expect to enter into a written contract for services with the selected entity, upon terms negotiated

between the parties.

10. Copies of the design and project requirements are available from the Town Clerk and maybe reviewed at 1 G Elm St. Cokedale CO 81082 Tues-Thurs between the hours of 8:00 AM & 4:00 PM.

11. Priority consideration will be given to individuals and firms currently operating within Las Animas County.
