# Trinidad Golf Association asks City for assistance

Trinidad Municipal Course is one of the City's great treasures, but it often struggles financially due to high expenses and a limited revenue stream. Joe DeGarbo, a member of the Trinidad Golf Association (TGA), asked for a little extra financial help from the City at Tuesday's City Council Work Session.

DeGarbo said the TGA was doing everything it could to increase its revenues and keep its costs down, but even with revenues of approximately \$282,000 in 2014, it figured to end the year with a deficit of \$18,000. The City will contribute \$15,000 to the TGA as part of its 2015 budget, which represents a typical annual contribution from the City to the TGA.

The TGA established a \$60,000 Certificate of Deposit (CD) a few years ago, he said, but it's drawn that down to \$20,000 today, and operates on a line of credit that must be paid back annually. It's raised

# John Schecter takes the reigns of TLACC for 2015

This week the Trinidad Las Animas County Chamber of Commerce (TLACC) announced their elections for the Board of Directors and Ambassadors. John Schecter, Office Manager at DigiCare Hearing Solutions, has been named Chamber of Commerce President for 2015, replacing Tara Marshall who works in the City of Trinidad

Terms for the Board of Directors and Ambassadors, who are responsible for functions like new business ribbon cutting ceremonies, are for one year. Schecter had formerly acted as Secretary for the board.

Other TLACC elected officers include President Elect Linda Barron Steele, who owns several local businesses including Mountain Liquor; Secretary Karen Tokar, who is a Vice President with International Bank; and Treasurer Jack Israel, a retired former employee of Pioneer Energy. Chamber Ambassadors for 2015 will include President, Cheri Jacobson, Vice President Sherri Files, Secretary Dolly Padilla and Treasurer Jack Israel.

"I want to continue to see the Chamber grow and become even more active in the community,' said Schecter Tuesday.

Like many civic organization in Trinidad, the Chamber seems



# Transferring from two-year to four-year college just got easier

Seamlessly transferring from Colorado's community colleges to four-year colleges and universities is now easier after actions by the State Board for Community Colleges and Occupational Education. The SBCCOE recently approved nine additional degrees with designation to accompany the Statewide Transfer Agreements recently approved by the Colorado Commission on Higher Education. In 2010, the Colorado Community College System sponsored legislation to require seamless transfer for community college students into four-year, public institu-

These agreements allow students to transfer the credits they earn at a community college to a four-year institution, avoiding the need to retake courses, saving students money and reducing debt as students pursue their higher education. These transfer agreements and degrees with designation also save taxpayers money as students are not taking courses that are unnecessary in pursuit of their

degree. The degrees with designation also allow a student to focus on his or her specific field of study at the two-year institution and seamlessly transfer to a four-year institution

"The SBCCOE approval allows the Colorado community colleges to offer nine more degrees with designation for our students, notably degrees in the much needed science fields of study. We now have 28 degrees with designations and statewide transfer agreements covering the vast majority of majors for community college transfers to a bachelor's degree. An important priority for the Colorado Community College System is to keep tuition low. With tuition of \$3,747 per year for a full-time student, taking the first two years at one of our community colleges, then transferring to four-year institutions saves families tens of thousands of dollars in their pursuit of a bachelor's degree," said Dr. Nancy McCallin, president of the Colorado Community College System. "The transfer and degrees with designation initiatives are important be-

cause the more certainty and

focus a student has through-

out his or her educational career; the more likely he or she is to complete a degree in a timely manner. This leads to improved student success in the forms of higher comple-

tion and graduation rates.

"Our top priority is to offer a learning environment that motivates students toward the completion of their goals," added McCallin. "With the guaranteed transfer of the credits that degrees with designation offer, students know that the time and money they invest with us will pay off in the future. We are excited and pleased to open additional opportunities for our students."

The new degrees with designation are: Chemistry,

Biology, Physics, Art History, Horticulture Business Management, Studio Art, Theatre, Music, and English. Some of the degrees already in place are Business, Elementary Education, Economics, Criminal Justice, and Agricultural Business.

The Colorado Community College System comprises the state's largest system of higher education serving more than 151,000 students annually. It oversees career and academic programs in the 13 state community colleges, including Trinidad State's Trinidad and Alamosa Campuses, and career and technical programs in more than 160 school districts and six other post-secondary institutions.
